

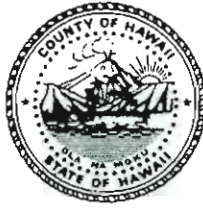

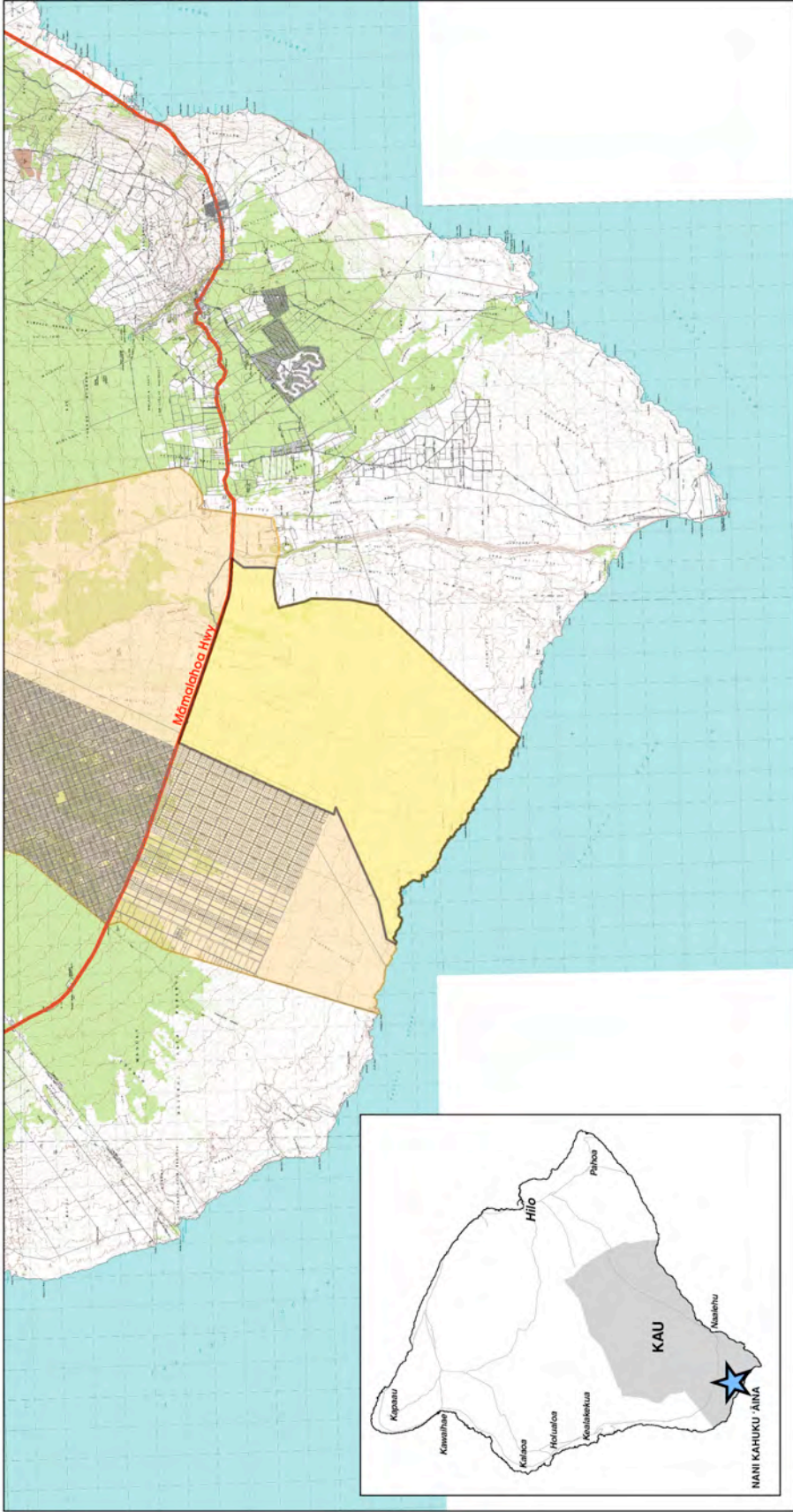

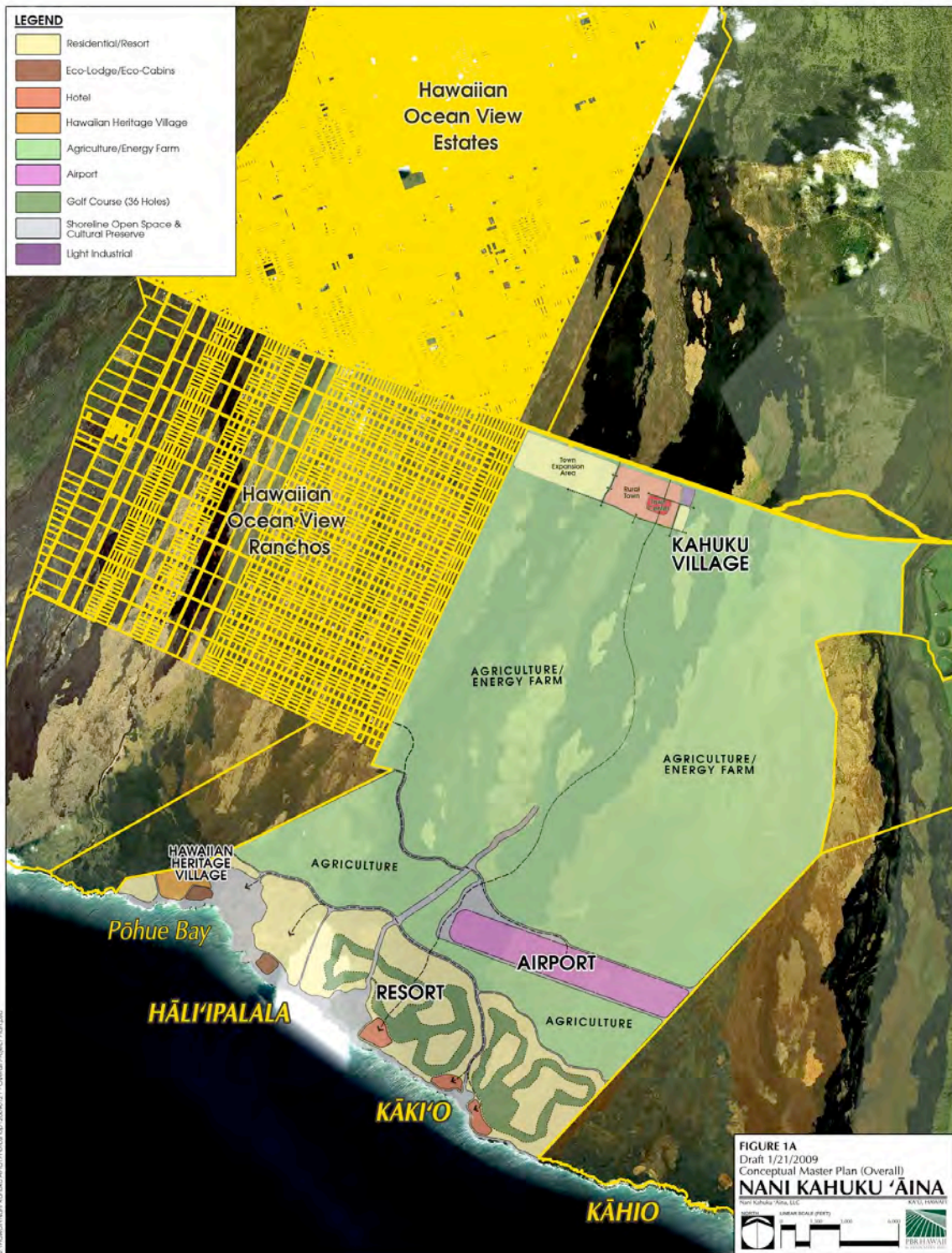

1989 LUPAG MAP FOR THE PETITION AREA

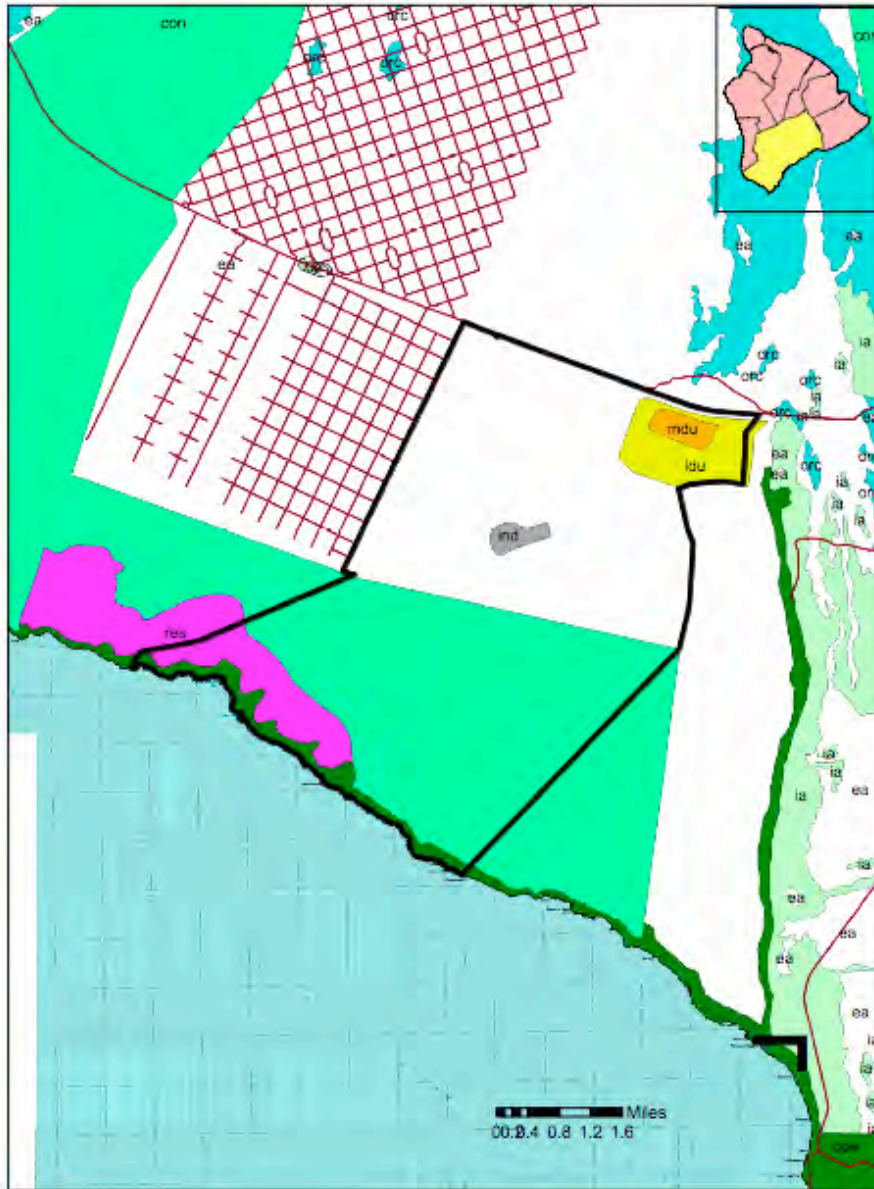
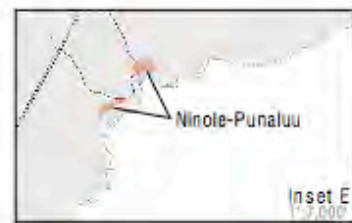
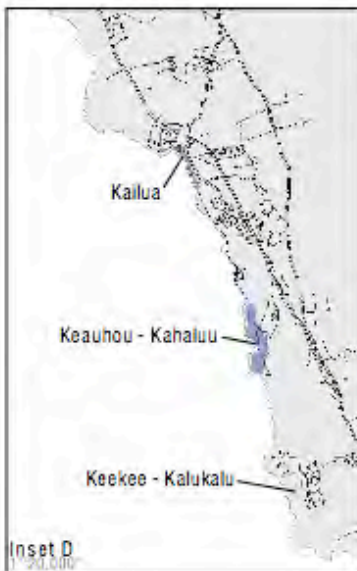
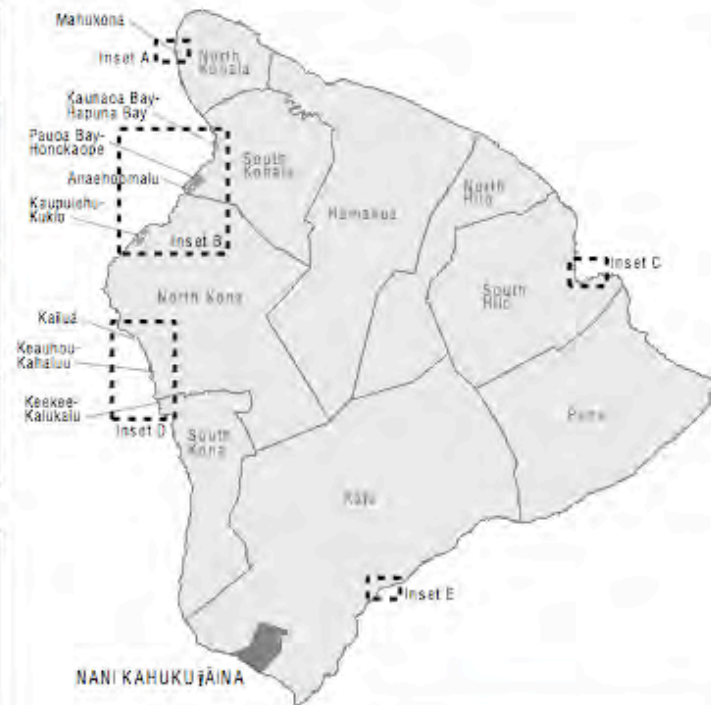
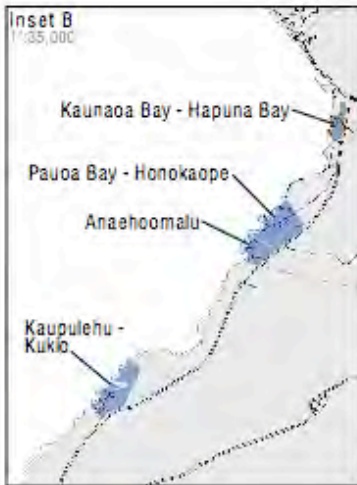
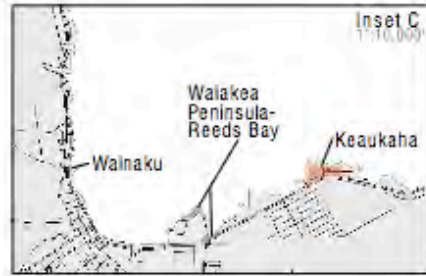
